The Institute takes a holistic view of all aspects of the property industry, with a focus on residential housing. We regularly engage with all three levels of government in discussions relating to new legislation, infrastructure priorities and our shared challenge of accommodating population growth across our state, and our members regularly consult with residents, communities, and neighbourhoods across Queensland. Our focus is to help build sustainable and vibrant communities for our growing state, and to contribute to planning and policy discussions which shape and preserve the way we live now and into the future.













PRESIDENT'S REPORT

The last couple of years have presented some increasingly difficult and complex challenges for our industry.



To overcome these challenges, we must continue working hard. Through the ups and downs, the Institute has spent 2023 tirelessly championing the role our industry plays in providing housing to the hundreds of thousands of new Queenslanders we're welcoming each year.

In 2023 we continued our role as your voice as we represented our industry to Government and the community. It was certainly a year of significant advocacy activity and policy reform, against a backdrop of continuing challenges for our industry, homebuyers, and renters across the state. Members have continued to encounter difficult market conditions led by a decline in head contractors, acute skills and trade shortages, and continuing construction cost pressures.

Our focus has been on ensuring that the reforms and new policies being considered are aimed at the right areas: the areas that will address the root cause of the housing crisis and will boost the delivery of housing supply, not hinder it. As always, we've been working with all three levels of government and utility providers as they have a role to play in reform, as does our industry. We're now seeing some positive activity, but there's still work to be done particularly in the areas of approval timeframes, infrastructure funding, work on zoning and levels of assessment, and planning scheme policies.

With the large number of people expected to call Queensland home in the coming years, members were awaiting reviews to local planning schemes outlining changes to accommodate the projected population growth. There were announcements

that all Regional Plans would be reviewed, starting with Far North Queensland, and the Wide Bay Burnett Regional Plan was delivered in December. The final Plan maintained a strong focus on protecting the environment, supporting economic growth, and the supply of diverse housing. The Institute recognised the need to 'identify and assess potential future growth scenarios, relative to future employment, servicing efficiencies, natural hazards, and biodiversity, and landscape values' for both Bundaberg and Fraser Coast.

The much anticipated update to *ShapingSEQ* was announced in December 2023. The finalised *ShapingSEQ* Regional Plan Update includes a number of changes to boost housing as a direct result of Institute advocacy including an expanded urban footprint, additional potential future growth areas, specific housing typology targets, a bolstered implementation program, including plans for more transparent, accurate, and regular land supply reporting and a more realistic approach to modelling the financial feasibility of projects.

Despite those challenges, our industry has continued to deliver homes and communities for Queenslanders. The Institute is ready to continue its work as your voice in 2024 and help you do what you do best, create homes for families of all shapes and sizes.

CEO'S REPORT

With your support and confidence, we've led the call for changes our industry needs.



In 2023 we continued our role as your voice as we represented our industry to Government and the community.

It was a year of significant Institute advocacy activity, in particular, we engaged with Government on the review into the role of the property developer, sunset clauses, management rights, scheme termination, the draft SEQRP review, and inclusionary zoning.

We've been at the table for Housing Roundtables and the Housing Summit, working tirelessly to ensure your views are represented at the highest level. Our focus has been on ensuring that the reforms and new policies being considered are aimed at the right areas: the areas that will address the root cause of the housing crisis and will boost the delivery of housing supply, not hinder it.

As we do every two years we refreshed our regional Branch Committees for 2023-25. After a record-breaking number of nominations for a position in our 12 branch committees, we were pleased to welcome over 130 volunteers. The Institute's strength is in our regional representation as well as the breadth of experienced professionals, inclusive of those on our policy committees, who give up their time and volunteer their knowledge; they have demonstrated their commitment to their industry and local community.

In addition to regional Branch Committees, and in response to the South East Queensland Regional Plan review, during the year we formed a new policy committee of highly skilled experts to provide an onthe-ground, evidence-based approach to the review.

The new SEQRP Committee will analyse the measures in the Regional Plan within the context of land supply, affordability, market acceptance, housing diversity, and infrastructure planning and delivery. The committee provides measured, pragmatic, and realistic solutions to directly assist in addressing the land supply and housing affordability crisis.

Communicating our industry's contribution is one area that deserves all our attention. We launched the Made for People initiative to help our members communicate how Queensland development benefits the lives and communities of everyday Queenslanders.

The initiative is an opportunity for those with negative perceptions of development, and developers, to uncover the true value of Queensland development projects, as it celebrates the extraordinary value development brings to the enriching lives and communities of Queenslanders. While focusing on the craft required to create quality development projects, Made for People also highlights the beneficial outcomes that flow from these projects.

Lastly, I'd like to thank the industry professionals who make up the UDIA Queensland Board of Directors for the time they dedicate, and the investment they make in the Institute. We're grateful for their contribution, advice, and ongoing support.
